

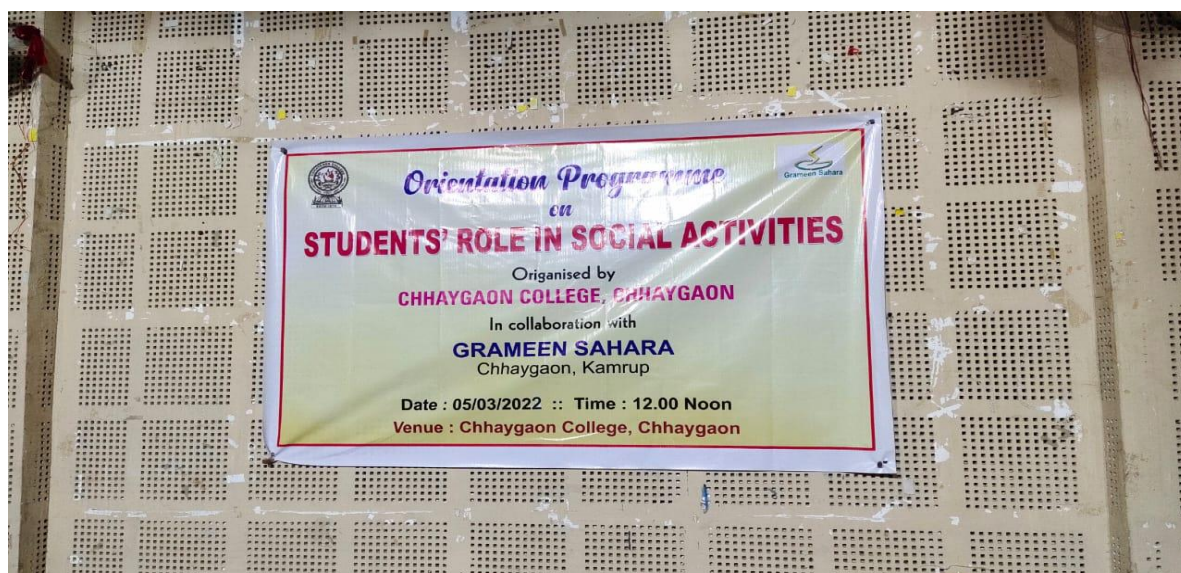



PURPOSE OF MOU


In particular, this MOU is intended to

Clause 1


SCOPE OF THE MOU

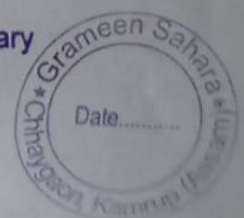
- 2.1 Both parties believe that close co-operation between the two would be a major benefit to the student community to enhance their skills and knowledge.
